Clinical Column

Does psychiatric terminology apply to the very old human being in the final Resolution struggle of life?

Psychiatric Evaluation: Molly Thomas, age 85, is suffering from delusional symptoms. She is accusing her male caregiver of raping her. Her paranoid delusions often extend to the male physical therapist who sees her once each week, insisting that he is stealing her clothes. Her daughter claims that Mrs. T. has always been "extremely proper and puritanical," never mentioning sexual matters." I have prescribed Mellaril and distraction to dilute her delusional state.

Physical Diagnosis: Alzheimer's Dementia, Osteoarthritis, Vascular disturbance. Mrs. T. has complained of dizziness. Her caregiver claims that she is increasingly restless.

Validation Worker's report: I have been seeing Mrs. T. for one hour for the past three months. Since receiving Mellaril, an antipsychotic medication, her accusations have increased.

Social History: Molly T. is the oldest of three children. Her parents emigrated to the U.S. from Germany in 1936, when Mrs. T. was 6 years old. Mrs. T. cared for her two brothers while her mother worked in a shoe factory. Her father, according to Mrs. T., was very strict. She never dated, and was forced to marry at age 16 to a man 22 years older.

Current Situation: Her brother, Joseph, died two months ago. Her youngest brother lives 300 miles away and she never sees him. Since the medication has not helped, the psychiatrist has agreed to stop the medication while I tried Validation. Here is an example and a summary of our contacts and some of the Validation Techniques that I used during the past three months:

Mrs. T.: Did you see that hairy young man?

Validation Worker: (Using the Preferred Sense, Centering, and Empathizing with Mrs. T's fear) "What does he look like?"

Mrs. T.: He has big hands, and sometimes, he has no clothes on, and his "thing" is so big. (Her voice trembles with fear, as she gestures, describing the size of his penis.)

Validation Worker: (feeling Mrs. T's fear, establishing trust, rephrasing with empathy) "Is it that big?"

Mrs. T.: nods, her eyes fill with tears. They share a moment of silence. Mrs. T. takes the Validation worker's hands and cries, silently.

Each week, Mrs. T. shares her fears with the Validation worker, who listens with empathy and helps her express her anger and fear. The caregiver and physical therapist report, after three months of Validation, that Mrs. T.'s accusations have lessened. She often jokes with them calling them, "good boys after all."

Mrs. T.is not cured of her fear and anger at men, but her feelings have lessened considerably. She has not accused the men of hurting or robbing her for the past four months. I have taught her daughter the Validation techniques that have helped.

Validation Theory: When a very old person, who has lost clock time, returns to the past, and substitutes a person in present time, for someone in the past, they have entered the final "Resolution Struggle." We do not call this a "delusion," rather a struggle to resolve unfinished issues and express emotions that have been suppressed for a lifetime.

An important *Validation Principle:* "When deep feelings are expressed, and validated, the feelings subside and the old person is relieved." The very old person in this final Resolution Struggle is trying to heal. The Validation Worker may never know what happened to Mrs. T., but the worker does know that she never expressed her fear of sex and her anger at the man who hurt her. In old age, Mrs. T. is struggling to ease her hurt and pain in order to live and die in peace.

New Development for Validation Teachers and AVOs

We've developed a new 'Modular Learning Curriculum' especially geared for training in nursing homes and other in-house learning situations. Many care facilities have the mission to maintain respectful, home-like residences for older adults. The caregivers, who work in their memory care units need to be trained to work 'person-centered', specialized in working with people who have various forms of dementia. This curriculum offers that in a flexible, economical way and still maintains VTI quality standards. It is an answer to an often expressed need from professionals and managers.

There are four 2-day modules; each is self-contained, meaning participants gain new skills with each module and could possibly stop after each one.

If a person completes all modules successfully, and demonstrates consistent practice of skills learned in between each module, he or she will be eligible for Level 1 Worker certification.

It is possible for there to be one year in between each module. Intervision or supervision between modules helps keep skills sharp and motivation high.

Participants are evaluated at the end of each module; successful evaluation leads to the award of an official diploma and entry to the next module.

The package includes:

- a curriculum with exercises
- power point slides
- video clips
- evaluation forms, instructions plus diplomas for each module
- materials, written exercises and handouts

The Price is \$500 for teachers and \$1,000 for AVOs.

New Course in Upper Austria

We are developing a new course called "Validation Assistant." It is an intermediate course between the ground courses and the Level 1 Worker course. The course will consist of 64 hours learning time. Instead of teaching in a classroom we will teach in an elderly home. The course will take place in an elder's home so that the teachers can point out how the Validation Worker is communicating with the elder in a validating manner.

Twenty four people have signed up to take the course. We will split them into 3 groups with 8 people in each group. We will teach them how to begin speaking with elderly disoriented people using day to day communication and an empathetic attitude based on Validation. By the end of the course, the student should have a validating attitude, can watch and give information to the Validation Worker or Group Leader to help support them, but not validate on the same level as a Certified Validation Worker.

This is a pilot project we will begin this year and finish at the end of 2017. There are many elderly homes that are interested in this form of learning Validation.



European Validation Association Symposium in Reims, France 18, 19 October 2016

When it occurs, the disease—especially Alzheimer's—takes over all spheres of our lives: emotional, social, professional, family, and so on. It immobilized the sick person; it hinders their freedom of movement, relations and action. Too often, our medical and social answers appear to be just another constraint, based on protection and security. Placement continues to be used a lot! Our job is to try and find new ways of working, accompanying, caring which don't add constraint over constraint, but rather propose freedom in such difficult situations. We have to try and move from liberticidal ties to liberating bonds.

The European Validation Association, in collaboration with the *Institut de formations M&R* will hold its annual Symposium in Reims (France) on the 18th and 19th of October 2016. At this occasion specialists from different horizons, neuropsychologist, R.N., sociologist, philosopher and many more, will share their acute perspectives on the bond issues. We will also have the pleasure to listen to International Validation Masters and Teachers: Vicki de Klerk, Hedwig Neu, Wolfgang Hahl and Mathias Hergué.

New Course for Family Caregivers

Family caregivers struggle every day to give their loved one the care he or she needs. Whether they are caring for a loved one at home or ensuring their good care in a facility, many of the same worries and problem situations arise. This training offers new ideas; new practical skills and promises to change the way family caregivers interact, communicate and maintain a loving, close relationship with a relative who has Alzheimer's disease.

This course combines:

- 5 taped classes that offer information and end with exercises that reinforce ideas or skills.
- Interactive Webinars extend the knowledge learned in taped webinars and offer participants the opportunity to express their feelings and exchange ideas with others in the course.
- A private discussion board offers participants the opportunity to share events and network with others 24/7 to combat feelings of isolation.
- A 2-day in-person training where participants practice Validation techniques with the teacher.

Participants can expect to spend approximately 1 hour per week for 12 weeks.
